Winter League Rules 2018/2019

Introduction

The aim of the Winter League is to sustain an interest in tennis throughout the winter months. Whilst played in a competitive format, the objective of the Winter League is to be more informal than its summer counterpart. For this reason, the following brief rules will form a basic guideline to the competition:

Rules

1. Matches will be played on Saturdays and Sundays starting at either 10 a.m. or 1 p.m. between 1 October and 31 March. Times may be varied by the mutual agreement of teams.
2. All matches will consist of six rubbers of twelve games. The order of play is shown on the scorecard.
3. Teams will be awarded two points for a win and one point for a draw. The match winner is determined by the **number of games**. When formulating final league positions, if any clubs score equal points then number of games will be counted, and (if necessary), number of rubbers.
4. Conceded matches will score 2 points to the winner and nil points to the conceding team.
5. The results of the match will be communicated in writing by the home team to the Fixture Secretary within seven days of the fixture.
6. A Club having more than one team in the competition must nominate their best players at the beginning of the season to be 'starred', two men & two women, who may play only for the 'A' team but not for the club's 'B' team. The 'A' v 'B' fixture should be the first of the season.
7. As a common courtesy to other teams, if a Club is unable to field a team for a match, or requires to cancel for any reason, the Captain of the cancelling Club **must** make contact with the opposing side's Captain, **at the earliest opportunity**, to advise of the cancellation. 'Making contact' is to be construed as actually speaking to the other team's Captain or leaving a message that is responded to in a way that makes clear notification of the cancellation has been received and acknowledged.
